### Feature Article In Praise of Librarianship

What are you doing now, pal? If the answerer, of this interrogation of a classmate of one's early college days now a successful businessman, comes as 'librarianship', the interrogator might not be ascertaining the latter's position. They may just wonder of a teacher-like or clerk-like or between those positions. The works and social status of, and demand for the fellow may attract pity or amusement, or a muddle of both.

This is not the story of one pal's reaction; many myths and realities are associated with this profession. Most of the people of different rungs and walks think it is a book lender's job, and nothing beyond that. And in country like India librarianship is in identity crisis.

What the teacher of Dawnkinster II showed in his slides in a classroom is paraphrased as "Librarianship is a noble profession. We've all experienced what libraries have provided to us while growing up. Librarians are the gateway to the world of information; librarians make society more humane and more democratic. But librarians aren't held in much esteem. Many of you, when you told friends and family that you were going to school to become librarians, suffered the jokes and confusion of people outside the profession. Some people probably questioned your sanity and your economic future. Librarians aren't valued by society, and aren't compensated well. Your rewards won't be evidenced by your rate of pay. You're answering a higher calling; you'll be providing a service to society."

Steven Bell cracks on this issue—"While working academic librarians are far from destitute, I know the salary spectrum pretty well, and many who've worked in this profession for 20 or more years still make less than a first-year could complain about the inherent unfairness of the situation, but as realists we know that society places limited value on those who work in the field of education. Nonetheless, college graduates and second-career seekers want to be academic librarians". He does not stop there. To supplement his observation he inscribes—'Making the decision to get a library degree is, I think, not entirely rationalanalytical. There's a strong emotional component. Whether it's a love of books or a passion to serve the community that drives the decision, librarianship is still a respected, compassionate and dignified career-a noble profession. It's about making a difference, helping people, being part of something bigger than oneself, and improving the quality of the community. We connect emotionally with our work.'

Despite above disparities of pay and position convolution *Library Journal's Academic Newswire* reports on annual Salary and Placement Reports for 2010 and 2011 say that the total number of LIS graduates declined slightly in 2011, but there were still close to 5000 new librarians were entering the job market of United States.

Many those think that Internet will replace library and Google (or any of the search engines) will replace librarian. But Jamie McKenzie's observation is different. She remarks—"While the Internet offers many treasures, it also confronts the erstwhile researcher with plenty of rubbish. There are those who have compared it to a huge information landfill." And assessing the virtual truth of Google, --Search engines like *Google* really are remarkable, but they do not offer reliable information in all cases. Without training in search logic, many users wander about drowning in data that may be distorted, inaccurate, irrelevant or biased." The preceding sentences are illuminating the real self of Internet, library, Google and librarian.

There is discussion that who should be a librarian; either a university degree holder or a learned person of a given subject—this is how some non-librarians have been arrogantly capturing librarians' positions in various universities. "The librarian of today, and it will be true still more of the librarians of tomorrow, are not fiery dragons interposed between the people and the books. They are useful public servants, who manage libraries in the interest of the public. . . Many still think that a great reader, or a writer of books, will make an excellent librarian. This is pure fallacy"---says Sir William Osler. Librarians have been sustaining much criticism from people of various walks despite their noble service to mankind. If the learned community does not recognize librarians' service and venture to discourage them or curtail their population in the pretext of some unknown reasons it is alarming the society will experience, in the words of McKenzie, "intellectual disarmament."

Gandhi Institute of Engineering and Technology (GIET), Gunupur, Rayagada of Odisha was established in the year 1997 with only two hundred odd students and now it has been flourished into one of the best technical institutions of India with more than four thousand students from India and aboard. The central library of GIET is known as "Knowledge Centre". Everybody knows that library is one of the central pillars of an intuition. So

GIET's Knowledge Centre is situated in the middle of the campus so that users can use the library at any time. The total seating capacity of the library is around 400 and extension of building is going on. The knowledge Centre of GIET has circulation section, reference section, digital library, photocopy unit, teacher reading room, property counter, librarian's office and back volume section.



One of the most important point of this library is its reference section which is open round 365 clock and 24 days hours; even most of the boarders

of the hostel use this library whole night. The library is automated with the Llbsys Software, and it provides the Web-OPAC and OPAC facility to its users. The Knowledge Centre of GIET has more than 8000 of titles of the different disciplines. One of the specific features of this library is that besides the academic books it also provides the fiction, nonfictions, biography and other inspirational books to its users. Besides the central library each and every department have a separate library for the ready reference. The library subscribed to 35 magazines and 20 newspapers of the different languages like Odia, English, Telugu, Hindi and Bengali.



The Knowledge Centre of GIET has given importance to web based resources, it subscribed to different e-journals like

IEEE, ASME, ASCE, Science Direct and Springer and few journals from the Indian Journal.com every year as per the AICTE norms; it also subscribed to different print journals of national and international publishers. This library is a member of DELNET since a decade. It provides the web and video courses of NPTEL, and previous year's university question papers and lecture notes of different faculties through the intranet as soft copy and hard copy also.

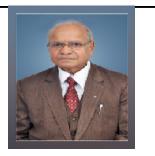
